## Important Project of Common European Interest - IPCEI Matchmaking

Member state selected organisations, known as Direct Partners, are seeking collaborators to join their project consortia and unite in response to the EU's IPCEI on Health initiative. **If you can contribute to the development and production of advanced therapies and/or Active Pharmaceutical Ingredients (APIs) – this is the opportunity for you.** The type of expertise needed is very wide: tools to monitor production, new methods of production, digitalisation, clinical knowledge, etc.

A series of bookable **Matchmaking appointments will then take place across 6 – 10 March**. This is when you can connect with the newly formed IPCEI project consortia and seize the opportunity to put your organisation forward as an indirect project partner.

### Which types of Partners are the IPCEI consortia looking for?

The IPCEI on Health represents a **significant investment in the biomanufacturing field**. The first wave of this initiative, **Med4Cure**, is focused on the development and production of both advanced therapies (such as vaccines, cell therapies, gene therapies) and APIs (Active pharmaceutical ingredients) and is defined by four workstreams, which you can read more about [here](#).

**After presenting Med4Cure** to the European Commission in November 2022, pre-notified projects are now finalising the **consolidation of their consortia with European partners** and looking for indirect Partners with an interest in any of the four workstreams to join them.
